

REPORT FROM THE BOARD ZOOM TELECONFERENCE

Minutes of Board Meeting May 25, 2022

President Luke Chaplin opened the May board meeting via Zoom at 7:30 PM. In addition to Luke, those present were Paul Bjarnason, Gene Rainville, John Dougherty, James Kolody, Greg Shepherd, Stan Johnson and Bill Sims. Absent were Doug Tomb, Bruce Metcalf, Benny Leonard, Edna Cross and Milford Sprecher.



John Dougherty stated that all tasks are completed for Sully. He is still in discussion with the Sully staff about placement of temporary fencing. Additional volunteers are needed for judging, parking, and the field set-up on Friday. One hundred thirty-four (134) show cars are already registered, plus four century-old cars registered with two more on the way. The Car Corral has three registrations, which may be a bit off from previous years. Car show interview at Sully for Channel 16 "Around Fairfax" is on 9 June, at 10AM. Paul Bjarnason, Jim Gray, and Eugene Rainville are bringing their cars for the interview.

James Kolody discussed the status of the youth scholarships. The applications have been reviewed. He recommended that the top two applicants receive \$1,000 and the other three applicants be awarded \$500 scholarships. A motion was made to add \$500 to the scholarship fund to accommodate this recommendation. Motion passed.

Paul Bjarnason recommended that the existing Treasurers Procedures Manual be modified to reflect last month's vote to permit use of Paypal and Zelle. Paul will re-send the proposed modified manual to board members for approval at the June meeting.

A discussion about whether the current board size is appropriate for the current Club membership. It was decided to add this item to the committee that will meet to discuss the future goals and procedures to be used by the Club in future years. That committee will begin work after the Sully Antique Car show is complete.

The Board discussed the advantage of publishing the Script each month on the Club website, in addition to the current email and hard copy publications. A motion was made and seconded to place a copy of the current Script issue on the website at the same time as other publication. Motion passed.

The meeting was adjourned at 9 PM.

He closed out his column by reminding those who sit in the back at meetings to please hold it down so as not to distract the rest of us from hearing what's going on. 'Nuf said.



At May's board meeting, held in Clem's "train room," he logged on to the internet and went to our new Club web page. Plans were made to develop a troubleshooting handout for those of us who break down on the road. Not sure if it ever came to fruition. The board also discussed the possibility of the Club purchasing an enclosed trailer to house a transportable, fairly large sandblast cabinet. There were lots of questions, which ultimately scotched the idea.

There was an article by Jim Cartmill concerning the importance of getting regular medical checkups. His procrastination had led to a brief battle with prostate cancer. Fortunately, it was caught early and we still have Jim with us. He also announced plans to host a visit in July to the Manassas Museum for its annual Civil War weekend, even though it would be the day before the Jaeger Sully Picnic.

Lloyd Hoffman, the Club Membership Chair, reported that as of the end of May the Club had 277 members and 310 A's and AA's. (Our current membership totals 156.)

There was a report on the June 1st sandblasting day at John Kandl's place down in Bealton, VA. The rain held off until they were just finishing up. Ten members took part and shared in the pizza lunch. At least a dozen wheels were straightened.

Clem reported on his chase for parts for his Phaeton, what he had collected so far (including 10 doors, 5 powerhouse generators, 4 brake systems, 4 sets of rear bumper brackets, and "a ton of ugly stuff with Ford script on it"), and his plans to sandblast it all.

Plans were reported for the tour to the MARC National Meet in Dayton, OH, June 23-27. Jim Cartmill was organizing it and taking care of the details.

Member Wayne Arny found an article on a new thing on the internet—an A's-only Model A Swap Meet for parts. The internet being a new-fangled thing, several paragraphs were devoted just to logging on and finding the website.

The June program would be the second of a 2-part series on touring. The first, in May, covered roadside troubleshooting. The June program would cover suggestions on what parts to carry when touring locally and on long-distance tours. The lists were published in the June Script for those planning to drive their A's to the MARC National Meet in Dayton.

Finally, the classifieds included a 1931 AA Dump Truck, all original except the paint, for \$9,000, and a 1931 late-model Sports Coupe for \$12,900.

Dave Henderson promises to return in July and resume his output of GWC history. No health issues—just house issues that completely wiped him out.



INFORMATION ABOUT MARC CLUB INSURANCE

Regional Director Newsletter May 2022

I have some great news for MARC members. Our President, Joe Valentine, and the MARC Board of Directors just negotiated a clubwide insurance policy with the Hagerty Insurance Company. The new policy is terrific. It will cover activities and events for all MARC members. The key word here being "MARC members". Just because you are a member of a MARC region does not mean that you are covered. Your non-MARC members are excluded from coverage. Only MARC dues-paying members are included. Let me repeat that. ONLY MARC DUES-PAYING MEMBERS ARE INCLUDED. What does that mean for your region? Any MARC regional member must be a dues-paying member of MARC. It is that simple. You can't be a nice guy or a pretty lady to qualify. You only need to pay your MARC dues.

It is still necessary for MARC members to carry auto insurance on your car. Property loss and casualty insurance is a must. You should check with your automobile insurance carrier to see what coverage your state requests and if you are entitled to a discount when you are a member of MARC. I contacted my insurance carrier and told them that I was a member of MARC. They verified it and I received a check back from them for \$28.00. It pays to be a member of MARC!! There are a very few events that may require additional insurance such as driving on a race track or for a timed driving event or a road rally. You will need a rider for these events. Please check with Hagerty first.

You ask, what does the new club insurance cover? Thanks to Cindy Ellenbecker, editor of *Nickel "A" News*, Nickel "A" Region for the following information:

"Question: Why would I be involved in a lawsuit in our Model A Club?

Answer: An accident can happen at anytime and anywhere and may cause an injury to another club member or maybe a public person attending or passing by an event hosted by your Region. If any MARC member is accused of being negligent or actually causing damages to persons or property or if an article by a member results in a claim of libel or a copyright violation, for instance, a lawsuit may be brought against the member, the Region and also the MARC National organization. Even if the MARC member is not negligent and someone gets injured (by falling, as an example) or the lawsuit eventually is determined to have no merit, the Region and MARC National still have to defend against those claims and that will cost a lot of money in lawyers' fees and expenses. The MARC policy is in place to cover these expenses. The policy also covers the amount of settlements and verdicts in the case of actual liability.

Question: What is covered by the new insurance policy?

Answer: All members of MARC National are covered against accusations that they were negligent or responsible for damages arising from their conduct or inaction. All MARC and Regional events are covered such as tours, parades, car shows, picnics, meetings, holiday parties, parts swaps etc. Please note that there may be instances when the venue or location of a particular event may require another policy or to be named as an additional insured on our

policy, such as a National meet in the U.S. where a parts swap is held, but MARC will not require a separate policy. Hagerty will assist in providing whatever is needed to secure the necessary insurance paperwork. Criminal activity, acts involving fraud, and intentional unlawful acts by MARC members are not covered.

Question: Are guests and family members covered by the MARC insurance policy?

Answer: Guests or family members of MARC members are not covered by this policy for their negligence or conduct unless they are volunteering to work for MARC during a MARC event. MARC's insurance will cover the Region and its member against claims that they caused the injury.

Question: Are non-members of MARC covered by the MARC insurance policy?

Answer: Any person not a member of MARC National as defined in the MARC Constitution is not covered by the MARC insurance policy. If your Region currently allows your Regional members to choose to not become a member of MARC National, those non-members are not covered by the MARC insurance policy. Those individuals are not recognized by MARC as members of your Region because Regions are mandated by the MARC Constitution to require MARC membership from their members. Non-MARC members who pay money to Regions are essentially providing a donation to your Region because they are not entitled to the benefits of Regional or MARC membership and that money may not be considered "dues." It is the responsibility of the Regions to make this policy clear to non-MARC members, who assume full responsibility for their personal liability concerns."

Your region is not doing your non-members any favors by allowing them to be members of your Region without being a member of MARC.

A member of another regional club told me of a situation that occurred with their club. It seems that one of their members, who refused to be a member of the parent club, caused a negligent injury to a third person at a club event. The third party sued and received a judgment against the non-parent member. The non-parent member had to pay his own attorney fees and a \$50,000.00 judgment. For \$50.00 he could have saved himself \$50,000.00 and attorney fees!!!! What a deal!!

TIPS FROM BRUCE HAYNES

If you have a problem with heating up at a stop light, install a fan shroud. It allows the air to flow over the entire radiator while the car is stationary. And, a 4-blade fan will significantly improve air flow at idle.

OUT & ABOUT WITH HONEYBUN & FERN

This is not a story about being out and about, but in a way, it is, except this time it is only about Honeybun ("HB"). Almost everyone in the Club knows Honeybun (HB), so no introduction is needed. Anyway, as most of you know, I am NOT a mechanic--do not play one on TV. HA! However, I am a bit of a Detective.

So, when Honeybun would quit after being driven about 15 miles or so, I tried to come up with a possible solution. Here's where my investigative skills kicked in. After driving HB around my neighborhood one day, I found that the radiator was SO HOT, I couldn't keep my hand on it. I thought: I wonder what could cause this. More thought brought more "humm." You know that moment when you think you might have accidentally stumbled onto a solution to a problem. I again said to myself: maybe the thermostat is stuck or the two little holes are clogged. Here's where my mechanical skills kicked in. I removed the top radiator hose & took out the thermostat. Note: Henry never had them in his cars. Another note: I have had this one in for about 16 years without any problems.

Now, as Paul Harvey always said, "Here's the rest of the story." I first drained the radiator, removed the thermostat, found that one of the little holes was clogged, one open. Replaced the hose with a new one from my stock of "A" parts. Refilled the radiator with one gallon of 50/50 antifreeze and 2 gallons of distilled water. Total: 3 gallons, in case anyone wasn't keeping count.

Test drove HB around my "hood." She performed like her "old self." No overheating. Next test was a drive of 26 miles to Cairo for the 34th Annual Great Southern Antique Car Rally on Saturday, May 14. HB made the trip without a hiccup. You couldn't see me smile but it was from ear to ear, as we pulled into the Cairo Grady Cultural Center. After breakfast, we drove about 50 plus miles on the Poker Run, around Grady County, again, without a hiccup. Except for a fuel line problem. That's another story for later.

More of the rest of the story: An article entitled "Avoiding Vapor Lock" appeared in May/June 2022 issue of the Restorer (a magazine published by MAFCA) went into great detail about Symptoms, Causes & Cures. So, here is where I had an 'Ahooga' moment. I have decided that Vapor Lock was my problem all along. Since I had never had it happen, I never gave it a thought. Happy Trails.

The 41st Annual 5T Tour Preliminary Meeting Plan

The 41st Annual 5T Tour is planned for Sunday, 12 June 2022. This tour will be sponsored by the MTFCI Chesapeake Bays Ts Chapter and will start from the Tuckahoe Steam and Gas Association Parking Lot Area, near Easton, Maryland and travel to St. Michaels, Maryland, mostly over seldom used roads, with a lunch stop there. Then continue to the Bellevue Oxford Ferry for a short Ferry Boat trip across the Tread Avon River to stop at the Scottish Highland Creamery for an ice cream cone, and continue back to Easton for a trip through the city on Washington Street, their original main street, and continue back to the beginning. All planned routes are west of US-50 and many are on seldom used roads. All the main roads have wide shoulders that will allow the Ts to pull over and let modern cars pass. Alternate Route directions from St Michaels and Bellevue, will be provided in the tour package to be used if the ferry is not running or backed up with a crowd. The overall tour length is about 50 to 70 miles, depending on what route is used or if the ferry is not used, and the road around is used to drive from St Michaels to Oxford.
