

TREASURER'S YEAR END REPORT

The year ending 2011 was another year which was financially executed close to plan. Monies received from club dues, Sully Father's Day show, activity ticket sales, 50/50, and interest was \$19,500 against a budget projection of \$22,451. These numbers do not include the \$3,984 collected during the Peyton Randolph auction which has been set aside for special scholarships in 2012. Expenses were \$17,810 against a budget projection of \$22,451. The net result is a carryover into 2012 of \$1,690.

A TRIP TO HIGHLAND COUNTY
or
A ONE-CAR CONVOY TO VIRGINIA'S MOST MOUNTAINOUS COUNTRY

It has been a year since finishing the Victoria's restoration. I decided it was time to put the car to a moderate test on a moderately long trip. I realize going it alone is not the wisest of decisions, but after all, this was Virginia and not some wild, untamed wilderness. I decided to go. And so last November I did.

My plan was to travel to Monterey, Highland County, one day going down and one day back. My route was to follow blue roads through the Blue Ridge Mountains, down to Staunton, then west via Hwy 250 to Monterey. The trip down was cool (in the high 40's) but otherwise uneventful. I was delighted to find a treasure in a Waynesboro antique shop, a Model T tire pump among the furniture. That "find" was success enough to make the trip more than satisfactory. I pressed onward and arrived in Monterey before dark. The car performed very well - over several high mountain passes without downshifting. This included Shenandoah Mountain (2936 feet) on the Highland Highway between Staunton and Monterey.

When I arrived, I became aware of a factor that could not be ignored—the weather. The weatherman predicted a hard freeze that night, into the low 20's. I put that out of my mind for a while and concentrated on photographing my Victoria posed before the Highland Inn. This ornate hotel was built in 1904 for the wealthy as a place to escape the summer heat of the lowlands. I stepped into a shop across the street to see if they sold antifreeze. They did not. However, before I left, the shop owner inquired if the antique car across the street was mine, which I confirmed.



"What is the year of manufacture and how many cylinders does it have" he asked.
"It was made in 1931 has 4 cylinders," I replied.
"Just like a Model A", he quipped.
"It is a Model A" I said.

“No it’s not”, he said. “The rear silhouette of the Model A is much squarer than yours. I know because I have seen many.”

I thought of continuing the argument but I could see little benefit in it. I left it at that, and continued my search for antifreeze.

I found some antifreeze and prepared to add it to my radiator. Before doing so, I started the engine to warm the system, readying it for the cold night to come. While the car was idling, it suddenly stopped! I was unable to restart the car in spite of all efforts. I added what antifreeze I could and hoped for the best. My only ability to protect the engine block from freezing was to cover the hood with a blanket and my jacket over the engine. I hoped for the best.

Next morning, the temperature was indeed in the low 20’s and there was ice in the radiator neck. I again tried to restart the car without luck. No spark to the plugs. That pointed to a bad coil or some other electrical anomaly. I disassembled the distributor checking for shorts. In doing so I broke off the tang to the condenser, so I needed a soldering gun. Benny Leonard provided some guidance by phone, so I set out to find a coil and/or a soldering gun. I tried two gas stations, an auto parts store, and electronic repair shop. In doing so, learned that there are no Model A Fords in the county, no 6 volt coils nor soldering irons available to borrow. I finally went to the high school/elementary school, which generously yielded a soldering gun.

Facts and Lessons Learned:

- Lesson: Carry an extra distributor or electrical components to rebuild distributor.
- Lesson: Bring a multimeter or circuit tester in your tool box.
- Lesson: Ensure your touring spare “parts kit” is complete (per the club recommended list)
- Lesson: Put your antifreeze in your engine early in the fall
- Fact: Highland County was named by the Scots Irish settlers and has about 3,000 residents
- Fact: The high school, junior high and elementary school share the same building in Monterey
- Fact and Lesson: It gets cold in Highland County in November – don’t ignore it.

To complete the tour I drove north on Hwy 220 to Franklin, WV and eastward over the mountains to Harrisonburg. It was very pretty, even though most of the leaves were off the trees. The rivers, hills and farms made up for the lack of foliage. From there, I crossed the Blue Ridge Mountains at Elkton, VA and then up Hwy 29 home. In all, it was a wonderful test of the car and it did very well, acting like a Model A for the most part. The car seemed to add a mystery challenge at an inopportune time, as they sometimes do - just to keep me on my toes. The entire trip of more than 400 miles was wonderfully refreshing and confirms that Highland County is worth a visit by one and all. But don’t go alone.

The library is a brick building surrounded by apartment buildings.


From Seven Corners:

HB 878 LICENSE TAXES ON CERTAIN VA VEHICLES


This bill is aimed at inoperable/unregistered cars not normally garaged or screened from view and increases the current \$100 license tax limit to \$500. Bill text is as follows:

Any locality may adopt an ordinance imposing a license tax, in an amount not exceeding \$500 annually, upon the owners of motor vehicles which do not display current license plates and which are not exempted from the requirements of displaying such license plates under the provisions of Article 6 (§ 46.2-662 et seq.) of Chapter 6 of Title 46.2, §§ 46.2-1554 and 46.2-1555, are not in a public dump, in an "automobile graveyard" as defined in § 33.1-348 or in the possession of a licensed junk dealer or licensed motor vehicle dealer.

Such ordinance shall exempt from such tax any vehicles which are stored on private property for a period not in excess of sixty days, for the purpose of removing parts for the repair of another vehicle. Nothing in this section shall be applicable to any vehicle being held or stored by or at the direction of any governmental authority, to any vehicle owned by a member of the armed forces on active duty or to any vehicle regularly stored within a structure.
