



Board Meeting January 28, 2026

President Milford Sprecher called the GWC board meeting to order at 6:00 PM. Board members in attendance: Milford Sprecher, Don White, Doug Tomb, Valerie Faircloth, Bill Sims, Bill Bass, Jeff VanGorder, Bruce Metcalf, Blane Adcock, and Dave Greenwood. This was the first meeting of the year and the transition board meeting, unfortunately the recent snowstorm prevented all the Board members from attending.

Treasurer: Doug outlined the process of developing the 2026 budget and is just closing the books on 2025. The 2026 budget will be built upon actuals for 2025 and the budget. Doug expects to have the 2026 budget ready for review and vote at the Members Meeting on February 18.

Activities: Valarie is working on the activities plan for the year and is in working out details for a October 25 picnic at Oak Hill. The ownership of Oak Hill has changed, and John Leydon is coordinating with the new care takers/ owners to work through final details and approvals. Doug reminded the Board that our insurance for such event is for GWC Members that are also members of MAFCA. It will be important that we stress national membership to anyone participating.

National MARC Liaison: Bill Bass presented to the Board the idea of hosting the May 2027 MARC national tour. Tentative dates would be May 5-7, 2027. The concept would be to headquarter the Tour at the Westfields Marriott in Chantilly near Dulles Airport. The Theme would be the "Historical Virginia Countryside Tour." The Friday tour May 7th would be to the Luray, VA, annual pre-war antique car parts swap meet. Other ideas were Virginia Winery tours, Skyline Drive, Big Meadow, and historical battle fields. The V-8 club of the metro area recently did such a tour and Bill Bass, Milford and Doug will contact them for ideas. It was a concern whether this would impact on our annual Sully car show, but it appears that the dates are about 6 weeks apart and should allow recovery time. If this goes forward, we will likely involve other area clubs in the planning and execution. Bill and Milford will be at the AACA annual convention at this Marriott in February and will make a preliminary contact with hotel event managers. Bill will discuss the concept with the national MARC board and get back to the GWC Board to further develop plans.

Script: Bill Sims said Script January articles are due February 2.

Old Business:

Dave is now compiling the mileage numbers for cars registered in the GWC/ MARC mileage awards program. It is very likely GWC will have cars that earned awards in 2025. He also reminded the Board that since all Board members are MARC members, the only fee to join is \$1.00. See Dave for an application.

The Next Board meeting will be on February 25. The meeting was adjourned at 8:42 PM

FEBRUARY 2001—GWC 25 YEARS AGO

In the From The President's Desk, President Jon Phillips spoke of his goals for the new year's activities. He noted the Club had 255 active members and observed that of that number, very few are actively involved in planning and development. His first goal was "to get more good people involved".

Jon mentioned the upcoming Pig Picking, Sandblast Day, Small Parts Day, and the like. He also wanted more volunteers for special events such as road trips, like last fall's tour. He thanked Jim Cartmill for his successful tour the previous fall.

His second goal was to get more speakers to share new information and ideas for the upcoming months at the Members Meetings. He wanted to be sure the members were provided with the information and help needed to further their interest in the hobby.

Editor Bill Sims announced that "my reserve is running low," and "the Script needs some good "filler" articles". If members provided the basics, Bill could do the rest.

In the Report From the Smoke Free Room, Dan Lyon reported that they wanted to encourage antique cars to remain until the advertised show time of 4:00pm at the upcoming Sully Show. Also, a concept of collector pins was conceived and would be introduced for the Sully Show. Jim Gray, Membership Chair, announced that 249 members had renewed memberships. Email auctioning of Model A parts was considered, but the logistics were too daunting to implement.

In the 25 Years Ago column, from 1976, they announced, "The 3rd Annual GWC Antique Auto Show and Flea Market is set for 13 June in conjunction with the Fairfax County Park Authority. The setting will be Historic Sulley Plantation on Sulley Road." Bill Worsham would be Meet Chairman again, and who knew this was the start of such a long run.

Mileage awards for 2000 were announced, with Paul Gauthier getting the top award with 730 miles driven, and Val Zadnik getting the award for the most Club activities attended in his Model A. The prize was a brand-new quail radiator cap to each one.

There was a warning article about safe use of a jack or jack stand when working on a car.

The Sunshine Report sadly noted the passing of Howard Minners' mother at age 97. Also, that Mazie and Bob Williams had gone to Florida for two months due to the recent cold weather. REBUILDING BRUCE'S ENGINE—ALMOST DONE

As noted in my last report, the rods were tight on the crankshaft. I took it back to Gunther's Machine to look over and fix. They ground .002" off the sides of the rods and shells and that fixed the problem. From there, the engine reassembly was normal. Next was installing the engine in the car. It was tougher than in 2020 for some reason, when I had the engine out for replacing the stripped cam gear. This time, I could have used the GWC frame spreader and had to lever the bell housing to the center. A neighbor who is a pro mechanic came over and helped me greatly. Removing the clutch inspection cover to see and rotate and line up the transmission shaft splines with the clutch disk was very handy. After helping Greg Shepherd a couple of years ago and this work has made me realize that the transmission has to be jacked up very high to get the flywheel housing face parallel with the bell housing to align things.

The rest of the assembly: generator, water pump, starter, etc. went pretty smoothly. The engine pans were their usual challenge. With the bolts pointing up, you need a way to hold them in place from below while you start the nuts




on top, then tighten them. My pans are spread a bit wide and I had to try the first bolt on each side in the three different holes to choose from. On one side I braced the pan in place with a piece of plywood (see photo right). To hold the bolts from underneath, I used my needle nose vise-grips and a strong neodymium magnet (see left photo). The magnet was also handy to hold the wrench on the nut on top inside the frame channel when I tightened the bolt from below.



The next step was to connect the hoses to the radiator. I fouled up by trying to push the hose on to the water pump gooseneck by pushing on the radiator. That broke the gooseneck and I had to get a new one, plus a new hose. I was gentler with it and no cracks! After that, the hood went on and the radiator support rods were adjusted. Now it is ready for clean-enough roads to start up and do some break-in and head re-torquing!

Overall, the job was cheaper than a pro rebuild from Schwalm's, etc. and a Burtz engine and I enjoyed the work involved. It would have been nice to avoid the extra block magnafluxing and the rod rework, but those costs weren't deal breakers. Wish me luck!

MY CARBURETOR IS LEAKING!

Tom Endy is a well-known Model A mechanical expert. He lives in California and edits *The Victoria Bustle*, the newsletter of the International Model A Ford Victoria Association. In the January 2017 issue he set forth a problem that many people misdiagnose. That problem is a persistent drip coming from the drain plug of the Zenith carburetor.

Tom explains the problem this way. "When the float valve does not hold sufficiently, the fuel level in the reservoir rises. At the same time the fuel level also rises in the main jet and cap jet until it spills over the top. It then runs into the throat of the carburetor and out through the small hole in the bottom of the throat. From there is runs back to the hex plug on the drain boss and drips off of it leading people to believe there is a fuel leak at the drain boss . . .".

So if you have a drip coming from the drain plug, and you have tightened it once, consider that the source might be a leaky float valve jet.

A VISIT WITH CHUCK ELDERTON IN SAN JOSE

Last month we went out to California to visit the grandchildren in the Santa Clara Valley. I am a member of the Santa Clara Valley Model A Ford Club, although I don't get to participate much as we are not out there very often.

One member of the club is Chuck Elderton. I met him at the MARC meet in Niagara Falls. He had driven his yellow 1930 Model A phaeton, Charlotte, from San Jose. It had a modified engine with a Weber carb and has logged over 100,000 miles on the car. I thought it might be fun to visit with Chuck when we were out that way, so we connected and set a time for the visit.

When we pulled up, the first thing we saw in his driveway was a purple Powell pickup! Powells were made by the Powell brothers, who, after WWII, came up with a plan to build pickups based on 1941 Plymouth frames and transmissions. A unique concept, for sure. They made about 150 trucks.

Chuck raced motorcycles for many years and all of his cars are modified to some degree or another. They are also set up for touring, with more comfortable seats, air conditioning and cruise control.

As for his cars, they are an interesting collection: three Model A's, a '35 Ford cabriolet (his first car), the Powell and a Chevy El Camino. He also has a 1940 Buick Brunn limousine that has not been restored but belonged to the parents of a girl he went to high school with. As for the other cars, Chuck shared this information about each one with me, plus his philosophy for modifying his cars. Each car has a name.

Chuck's philosophy is to modify the vehicles so that they can be comfortably and relatively safely driven on a daily basis - anywhere and anytime. He wants to preserve the spirit of the original car. All of his vehicles have the original style running gear and are modified and accessorized to meet his needs. These old cars are all that he drives. They have one modern car that his wife drives mostly. She used to drive his antiques, but not so much anymore. His cars are as follows:

Charlotte—1930 Phaeton: Driven 117,000+ miles since 2003 (when he started keeping track), original style drivetrain, mechanical brakes and original steering box. The engine is a Model A diamond block plumbed for oil pressure, SCAT crankshaft, Chevrolet 283 style pistons, Windfield 9062 grind on the cam, Snyder 5.5 head, Weber carburetor, Pertronix/First Street distributor. Stock transmission and rear axle (3.78:1) with a Mitchell 26% overdrive. The brakes have cast iron drums, molded linings, and Flathead Ted Floaters. The only modifications to the suspension are well lubricated springs, tube shocks, Teflon rod ends and the wishbone is split and mounted near the stock ball location with two Heim joints. Accessories include full instrumentation, 100+ amp alternator, air conditioning/heating (Vintage Air Compact), cruise control, and LED lighting all around.

Kermit—1930 closed cab pickup: Driven 41,000+ miles. Same drivetrain as Charlotte except the engine is fitted with a Serr-Miller overhead, Ross custom pistons (8.5:1), and Holley Sniper throttle body fuel injection/return fuel system. Modifications to the chassis and the accessories are identical to Charlotte.



Ol'Blue—1930 Roadster: A recent addition to the fleet only driven 27 miles home upon purchase. Currently undergoing a major refresh. He did a lot of work on this car to resurrect it for the prior owner in 2018 and purchased it from his estate in April 2025. This is an old Southern California hot rod. Notes found in the car have revealed part of its history from the 60's and 70's.



In 2018 it received new Lincoln-style hydraulic brakes, Posies lowering springs, a dropped front axle, tube shocks, etc. The engine was rebuilt (by another shop) pretty much stock, unknown cam grind, Thomas head, dual Stromberg 81's, and Pertronix/First Street electronic ignition to replace the WICO magneto. It was also fitted with a T-5 transmission and open drive at the same time. It is still a work in progress. He has clear-coated the old blue paint and is letting it fully cure before color-sanding and buffing. This is the only car without air and cruise.

Barney—1956 Powell Sportwagon Deluxe Pickup: The family workhorse has been driven only about 25,000 miles since built in 1998. It is modified in much the same manner as the Model A's. It is built on a 1941 Plymouth chassis, retains a Plymouth flathead six, has dual Holly 94 carburetors, Fenton headers/dual exhaust, Pertronix ignition, and a milled head. The chassis is modified with a Borg-warner overdrive, a Ford 8.8 rear axle, and power disc brakes on the front. Air conditioning, cruise control, full instrumentation, LED's, etc.

Chuck found the truck on some property his boss was renting. When the boss quit renting the property, the owner was going to junk the old vehicles on the property, including this one. As a true old-car guy, Chuck jumped in to save this unique and rare vehicle from the scrapper.

Rhett—1935 Ford Cabriolet: A fairly recent completion with only about 7,000 miles so far. Same formula: original-style running gear, and lots of modern accessories discretely installed. He has had this car since 1961. It sat in a pile for decades and was made road-worthy in 2019 and emerged from the body shop in 2021.

This car has a 276-cubic inch 1951 flathead V8, Holley Sniper EFI, Offenhauser heads and manifold, Isky Max-1 cam, MSD ignition box/distributor, 1939-style 3-speed transmission and 2-speed Mitchell 36% overdrive, stock steering, and four-wheel power disc brakes. It looks stock (original factory colors/wheels) except for the stance, which is due to a dropped axle and big/little tires. He installed a hyper-deluxe leather interior, which makes this car an absolute dream to travel in. Chuck and his wife drove it to Lincoln,



Nebraska, a year ago.

Caliente Negro—1984 El Camino: He built this car in 1996 by combining a used-up El Camino, and a wrecked new 1995 Corvette. In recent years this car is barely driven as the old cars are so much more fun (and work). It has the Corvette engine/transmission/computer, Camaro Z-28 steering box, lowered/upgraded suspension components, and four-wheel power disk brakes. All the accessories and a Conley Leather interior. Plush, reasonably fast, and handles like a go-cart.

Chuck does all the work himself except for final body and paint work. I was awestruck by this collection and all the work he has done.




